**Note:** No extension of cooling off period will be granted. If you require more time to reconsider your renunciation decision, please submit a withdrawal request before your selected cooling off period ends. There will be no refund of renunciation fee for withdrawals. If your request for withdrawal is received after your renunciation has already been processed, your request to withdraw will not be successful.

**30. Cooling Off Period: Please select your preferred cooling off duration**  
This period allows you to reconsider your renunciation decision and submit a request for withdrawal of renunciation of Singapore citizenship. If ICA does not hear from you within your chosen cooling off period, your application for renunciation will be processed.
